


## The Favorite Tactic of Criminals

When criminals fail in their attempt to control your free thought, *i.e. the absolute truth*, they will attempt to pull out one of their last weapons; "*he or she is crazy.*"

This was a favorite tactic of Stalinist Russia, if you managed not to get sent to the camps in Siberia, or were not located in the Bread Basket of Europe, you most likely ended up in a mental institution. This other blight on humanity, *i.e. the bread basket*, which can be compared to the native America holocaust, is referred to as the [Holodomor\(1\)](#) the [Ukrainian Famine/Genocide of 1932-33\(2\)](#)



This is another tactic used by the State of New York, *i.e. the same tactic used in the Soviet era*, when they would send people to psychiatric institutions in order to crush free thought. See in New York, they can forcibly medicate you, against your free will to shut you up. In the Soviet Union they used the term "philosophical intoxication", which was one of the more widely used terms to diagnose alleged mental disorders of that era. [Aleksandr Solzhenitsyn](#) was a perfect example, however he was sent off to the camps. Soviet "dissidents" were incarcerated in mental hospitals after being labelled with diagnoses of "sluggish schizophrenia", a disease fabricated by a man named Andrei Snezhnevsky, head of the "Moscow school" of psychiatry. In dozens of cases, he personally signed a commission decision on legal insanity of mentally healthy dissidents including [Vladimir Bukovsky](#), [Natalya Gorbanevskaya](#), [Leonid Plyushch](#), [Mikola Plakhotnyuk](#), and [Pyotr Grigorenko](#). In 1980, the Special Committee on the Political Abuse of Psychiatry, established by the [Royal College of Psychiatrists](#) in 1978, charged Snezhnevsky with involvement in the abuse.

But we must digress from these topics and focus on the current events which are unfolding here in this state, this is happening in New York where individuals are forced to undergo the injection of drugs and/or other types of 'treatment' in the attempts to shut them up. The most interesting thing about these types of events is that in a majority of cases the staff always sides with the individual stating their is nothing wrong, and they should not be locked up for their beliefs. However the doctors in charge will not agree and the staff must do as the doctor ordered of course.
