Of concern is the recent discovery of the fact that William Preston Marshall (Ex. 0001, 02), Erich Weyand (Ex. 0003,04) and Kelly Balcom (Ex. 0005) positions/appointments as County of Cattaraugus, New York Assistant District Attorney's are vacate due to them not filing an oath of office within the time allowed. This would also included Court Clerks Jane St. John (Ex. 0006) and Jillian Koch (Ex. 0007, 008) positions/appointments (Fisher v. State of New York, 10 N.Y.2d 60 (1961)<sup>1</sup>; Ritter v. State of New York (283 App. Div. 833 [3d Dept.])<sup>2</sup>.

The New York State Constitution prescribes the oath or affirmation to be taken by members of the legislature and by public officers, except such inferior officers as shall be by law exempted, shall before they enter upon the duties of their office [N.Y. Const. Art. XIII, § 1)<sup>3</sup>. Every officer is also statutorily required to take an oath of office required by law before entering upon the discharge of any official duty (Pub. Off. Law (PO) § 10, discussed in N.Y. Jur., 2nd Civil Servants and Public Officers and Employees § 85; County Law § 402), and until he or she does so, cannot exercise the functions of his or her office (In re Bishoff 80 A.D. 326, 80 N.Y.S. 917 (2d dep't 1903); New York Jurisprudence 2D § 61<sup>4</sup>. A notary public is a public officer (People v. Rathbone, 1895, 145 N.Y. 434, 40 N.E. 395 . See, also, People v. Wadhams, 1903, 176 N.Y. 9, 98 N.E. 65; Marzbach v City of New York 163 N.Y. 16 N.E. 96 (1900) (holding a notary to be a state officer); In re Searls 155 N.Y. 333, 49 N.E. 938 (1898); People v Rathbone 145 N.Y. 434 40 N.E. 395 (1895)). Oath of Office mandated (Carter v People (witherspoon) 77 N.Y.2d 95, 566 N.E.2d 119, 564 N.Y.S.2d 992 (1990); see also 53 NY2d 870, 871).

Depending on the Office held determines when the Oath is required to be taken. The United States v. Germaine (99 U.S. 509), inferior Officers.

- **Public Officers Law (PO) § 10:** every public officer to take and file the oath required by law before he or she performs any official duties<sup>5</sup>;
- **Public Officers Law (PO) § 15:** provides that a person who executes any of the functions of a public office without having taken and duly filed the required oath of office, as prescribed by law, is guilty of a misdemeanor<sup>6</sup>,
- **Public Officers Law (PO) § 30 (1) (h):** that an oath of office must be taken and filed before or within thirty days after the commencement of the term of office, if not the office/position becomes vacant<sup>7</sup>;
- County Law § 402: Every officer paid his compensation from county funds shall take and file an official oath in the manner prescribed in section ten of the public officers law. The refusal or neglect to take and file such oath within the time prescribed

by section thirty of the public officers law, except in the cases of the sheriff, county clerk and district attorney, shall be deemed a refusal to serve and the office may be filled as in the case of a vacancy. Until the sheriff, county clerk or district attorney shall take and file the required oath, he shall not perform any duties of the office, nor be entitled to any compensation.

The Official NY Department of State, Division of Corporations, State Records & UCC (<a href="https://www.dos.ny.gov/corps/oath.html">https://www.dos.ny.gov/corps/oath.html</a>) provides a detailed description in laymen's terms of the duty of public officers as to their oaths of office and penalties for failing to do so.

It must be noted that Marshall's and Weyand's oath only appeared after Defendant filed a FOIL request of October 5, 2017 for a copy of Marshall's Oath of Office (Ex. 0009). Marshall's alleged Oath clearly shows it was notarized on October 12, 2017 and Weyand's was notarized on October 13, 2017, indicating a concerted effort to cover up the criminal conduct of both Marshall and Weyand (People v. Connolly and Seely 253 N.Y. 330<sup>8</sup>; 171 N.E. 393; 1930 citing People v. Miles, 123 App. Div. 862, 875; affd., 192 N. Y. 541)<sup>9</sup>. ADA' Kelly Balcom's comes back "No Matching Documents Found" (Exhibits 1 though 5). Further the only oath found filed of a Marshall found is that of Bridget McCue Marshall (Ex. 0010).


